I. Department/CTE Grant Goal:

- SY 20-21 Grant Goals
 - 80% of Level I students will receive a B or better each semester.
 - Semester 1: 61.5%
 - 80% of Level II students will receive a B or better each semester.
 - Semester 1: 62.9%

II. Carson High School Academic Goal (Semester 1)

- Decrease the number of students failing classes
 - Level I
 - September 21, 2020: 22.1%
 - End of Semester: 11.7% (Decrease of 10.4%)
 - Level II
 - September 21, 2020: 18.7%
 - End of Semester: 8.9% (Decrease of 9.8%)
- Supports and Processes for both goals
 - Continue to support in CTE Professional Learning Community (PLC) meetings weekly.
 - Susan Roman, Career Center Specialist, compiles reports monthly and uploads to Google Classroom for all teachers.
